

Nemzetközi kapcsolatokkal is foglalkozó egyetemek publikációs témáinak vizsgálata

Napjainkban sokféle nemzetközi egyetemi rangsor létezik. Némelyek csak egyes tudományterületeket, mások képzéstípusokat értékelnek. A legelterjedtebbek a táblázatos megoldások, amelyek táblákat állítanak össze, szemléltetve a helyezéseket. Nemzetközi táblás értékelést ad például a QS-, a THE⁻¹, az ARWU⁻² és a Leiden-rangsor³ is.

A QS World University Rankings (QS) egyetemi rangsort a brit Quacquarelli Symonds cég állítja össze minden évben 2004-től. 2004 és 2009 között a Times Higher Education (THE) céggel közös listát készítettek. Azt követően a két brit cég önálló listával jelentkezik.

A 2014-es rangsor módszertana szerint az alábbi tényezőket vették figyelembe az oktatási intézmények sorrendjének meghatározásakor.

A QS rangsora a hivatkozási értékek számolásában és kutatói reputáció mérésében 2004-2007 között a **Web of Science (WOS)** nemzetközi katalogizáló adatbázisát használta, ezt követően váltottak az Elsevier tulajdonjában álló **Scopus** adatbázisra.

A QS rangsorok két alaptípusra bonthatók:

- általános,
- szakterületi.

A tématerületi vizsgálathoz 10 intézményt vontunk be, amelyek QS szakterületi listán jól szerepelnek:

- hármat az Egyesült Királyságból (SOAS University of London, University of Essex, University of Edinburgh),
- kettőt Hollandiából (University of Amsterdam, Leiden University),
- egyet Franciaországból (Sciences Po), Svájcban (ETH Zurich - Swiss Federal Institute of Technology), Olaszországból (European University Institute), Dániából (University of Copenhagen) és Magyarországról (Central European University).

Az első 10 vizsgált egyetemről elmondható, hogy 2009 és 2018 között, a nemzetközi kapcsolatok területén több mint 450 darab Scopus által indexált közleményt írtak az intézmény kutatói.

A vizsgált intézményeiben dolgozó kutatók 1 078 tématerületen publikáltak 2009 és 2018 között. Egy közlemény, egy szerző több tématerületben is szerepelhet! Minden téma 3 kulcsszóval (pl. „**Terrorism; Violence; Suicide attacks**”) és egyedi azonosítóval (pl. **T.3605**) rendelkezik. A témák nemzetközi hatása alapján 5 kategóriába sorolhatóak:

1. **TOP 1%**, amely magába foglalja azokat a témákat, amelyek a nemzetközi kapcsolatok területén a legolvasottabbak és legidézettebbek az adott tudományos diskurzusban. Esetünkben nincs ilyen téma.
2. **TOP 5%**, amelyhez tartozik az előbb említett TOP 1%-os tématerület, továbbá minden további nagyon jelentős tématerület, amely nemzetközi hatása jelentősen meghaladja az átlagot. A vizsgált intézményeinél összesen 14 ilyen tématerületet mutat a SciVal. (lásd a **mellékletet**)
3. **TOP 10%**, amelyben benne van az előző TOP 5%-os tématerület és ez kiegészül gyakran idézett területekkel. Összesen 40 tématerületet találhatunk a vizsgált intézményeknél (lásd a **mellékletet**).
4. **TOP 50%**, amelyhez tartozik az előző TOP 10%-os tématerület és ez kiegészül további 360 témával. Ezek a tématerületek is lehetnek jelentősebbek, de kisebb érdeklődést tudnak kiváltani nemzetközi szinten.
5. **Egyéb témák**nak nevezünk minden olyan tématerületet, amelyek jelenleg kevésbé olvasottak, alig idézettek, de megjelennek a nemzetközileg jegyzett folyóiratokban és könyvekben. Ilyen tématerület 678 darab volt 2009 és 2018 között a vizsgált intézményeknél.

A vizsgált intézmények kutatói 9 071, a Nemzeti Közzolgálati Egyetem és jogelődjeiben (National University of Public Service, NUPS, NKE) 23 darab közleményt írtak a kutatók 2009 és 2018 között ebben a tudományterületen. Minden esetben a közlemények absztraktja a Scopusban elérhető, a teljes tartalom a kiadók oldaláról letölthető előfizetés esetén. A közlemények hatodát (1 521 darab) az University of Amsterdam, nyolcadát a Leiden University (1 107 darab) és az University of Edinburgh (1 071 darab) oktatói írták.



A közlemények 15%-a (1386 darab) a **TOP 5%** kategóriába, 14%-a (1 311 darab) **TOP 10%**-hoz tartozik. A publikációk 50%-a (4 498 darab) a **TOP 50%**-ban található, a fennmaradó 21% (1 876 darab) az **egyéb közlemények** közé sorolható.

A **TOP 5%**-os és **TOP 10%**-os szinten az összes vizsgált intézménynél írtak legalább egy közleményt. Egyéb témák nagy aránya (26 illetve 25%) az University of Edinburgh és az Sciences Po -ról mondható el.

Összefoglalás

Az NKE-s kutatók számára fontos tudni, hogy egy adott területen melyek a nemzetközileg legrangosabb intézmények, és ott milyenek a legnépszerűbb kutatási témák. Közös publikálás a QS által listázott egyetem oktatóival akkor lehetséges, ha adott téma szakirodalmát megismerjük. Ebben segíthetnek a legnagyobb kiadók teljes szövegű közleményadatbázisainak használata és olvasása:

- Elsevier (Link: <https://www.sciencedirect.com/>),
- Springer (Link: <https://link.springer.com/>),
- Taylor & Francis (Link: <https://www.tandfonline.com/>),

A publikálásra benyújtott közlemények egy részét megjelentetik, másik részét elutasítják a folyóiratok. Az elutasítások egyik fő oka, hogy a benyújtott dokumentumok témái az adott folyóirat esetén nem relevánsak, még akkor sem, ha maguk a benyújtott közlemény kiváló egy másik területen. A közlemények témájához jól illeszkedő folyóiratokba való beküldéssel – több esetben – elkerülhető ez a probléma. Egy olyan informatikai rendszer, amely képes arra, hogy olyan folyóiratokat javasoljon, amelyekben hasonló cikkeket tettek közzé segíthet a szerzőknek abban, hogy hova adják be a közleményeiket. Ezek a folyóiratkereső rendszerek a legtöbb esetben egy szabadon elérhető online szolgáltatásként jelennek meg.

- a **nemzetközi trendeket** és az
- **adott terület jelentősebb intézményeinek a publikációs témáit.**

A **TOP 5%** és a **TOP 10%** tématerületen végzett kutatás és közleményírás magas hivatkozási számmal kecsegtet, ami hosszabb távon nemzetközi ismertséghez vezethet.
