<p><b>Course description:</b></p> <p>After 2008, the problematics of globalization, especially its current challenges in European continent became more and more worth analysing for subject matter experts.</p> <p>This course refers to the time-based dimension and heterogeneousness of Theory of Economic Governance and emphasizes some higher-level scientific problems of the state intervention tools, and for it.</p> <p>These lectures demonstrate the primarily the current problematics of economic development and dilemmas of state intervention to economy. **Learning outcomes and course competencies:**
