Course description	The course introduces the students into the history of local autonomies and governance both in Europe and Hungary via the legal and constitutional envorinment. Then the competences and the duties of the local government are introduced with special attention paid to the socal, economic and adminsitrative tasks, regarding the body of representatives, the committees, the notary and the mayor, vice mayor respectively. The function and the social role of the local governance of the national minorities are also exposed, together with the relevance of local democracy and local voting systems. The course also includes the budgeting and the financing of the local governments, the local development planning, urban marketing, the local electronic-government tools, the online communication and the inclusion of local population in the local decision making processes. Finally the local law enforcement and environmental protection is described.
